CHILD PROTECTION PROGRAM: This Port-au-prince based program reached approximately 1000 individuals by training and mobilizing adult survivors of child slavery in eight neighborhoods to promote child rights and end child slavery. Adult survivors were trained and supported to intervene and accompany children leaving slavery situations, start Village Savings and Loan Associations, perform popular theater productions to raise awareness, hold neighborhood campaigns, conduct advocacy, and train community residents in child rights. Seven children were reunited with families from slavery situations.

MODEL COMMUNITY INITIATIVE: Trained leadership and facilitated popular education and community organizing to protect children's rights and end child slavery in 84 communities. 51 children returned home from domestic slavery. Trained and supported 500 adult survivors of child slavery to organize and mobilize. Trained and equipped 25 schools to improve education quality and cultivate school gardens. Used evidence-based Graduation methodology to support 231 impoverished families to build sustainable livelihoods. Trained 450 farmers in sustainable agriculture, provided literacy instruction to 237 adults, and supported 15 community gardens. Conducted complementary programming to prevent violence against women and girls in seven communities.

THE MOVEMENT TO END VIOLENCE AGAINST WOMEN AND GIRLS : Mobilized eight communities to drive social change to prevent violence against women and girls (VAWG) and HIV using two methodologies: SASA! and Power to Girls. Provided training and technical support to 36 organizations to implement community mobilization in their own communities. Advanced research partnerships with Global Women's Institute at the George Washington University to measure impact, and with the University of California San Diego and Raising Voices to assess necessary inputs for successful adaptation of SASA!. Developed a curriculum to train journalists to promote prevention of VAWG.

Using approaches to catalyze shifts in social norms and build local capacity to lead movements for change, Beyond Borders' 35 program staff impacted the lives of more than 20,000 individuals during the fiscal year. The Movement to End Child Slavery Beyond Borders works to catalyze a broad social movement for children's rights, with a special focus on stopping of the practice of child domestic slavery (restavk). In remote, rural regions of Haiti, Beyond Borders' Model Community Initiative accompanies communities to protect, educate and feed their children in order to stop the flow of children into child domestic slavery. In urban neighborhoods, it works to build local volunteer structures to help children access protection services when needed, and to help children living in child slavery find their way home. In both urban and rural communities, Beyond Borders is supporting an emerging network of more than 800 adult survivors of child slavery who are using their voices to end the practice and intervening on behalf of children in need. In 2018 BB's Model Community Initiative (MCI) trained local leadership and facilitated popular education and community organizing to protect children's rights and end child slavery in 84 communities. 60 children returned home from child slavery. Achievements include: Implemented "Operation Zero Restavk" campaigns in 24 urban and rural communities, catalyzing seven communities to achieve Zero Restavk status, with no children living in child slavery in those communities. Expanded child rights programming into to seven additional communities on La Gonve Island and sixteen communities in Haiti's Center Department. Expanded the size and built the organizing and advocacy skills of the Network of Adult Survivors of Child Slavery, to facilitate their increased visibility as a leading moral force for ending the practice of child domestic slavery. Altogether, 804 adult survivors were mobilized through the Network. Regional coordination committees provided

leadership in Port-au-Prince, La Gonve, and the North Department, linking nationally to advance advocacy efforts. The Network held meetings with protection and family reunification agencies, held a march during annual carnival celebrations, and produced six public statements, 19 press releases, and seven radio interviews.

Supported the Network of 804 adult survivors of child slavery with ongoing training workshops to foster their own rehabilitation, and their capacity to intervene on behalf of children. Offerings included psycho-social peer support group sessions among survivors, and workshops on how to start and operate Village Savings and Loan Associations (VSLA). Survivors' Network members were also trained in first response services to children in need of protection, including referral systems, codes of conduct, and psychosocial needs of traumatized children. Trained 3,609 new child rights activists using a dialogue-based 22-session child rights curriculum designed to challenge norms and cultivate activism. Held 25 town hall meetings to mobilize communities to engage in the movement to end child slavery. Developed and delivered a training module for Child Protection Brigades to mobilize around Haiti's new anti-trafficking law. The new curriculum was used to train more than 300 individuals, including Survivors' Network members, members of volunteer Child Protection Brigades, community-based organizations, government officials, religious leaders, and justice sector representatives. Beyond Borders distributed 5,000 pamphlets. Trained and supported 84 volunteer Child Protection Brigades to lead community education campaigns and intervene to assist child victims of violence or domestic slavery, helping them access protection and family reunification services. Testimonies: I was sent to live with an aunt as a child; the only time she treated us well was when my mother came to visit. Any other time she treated us like we weren't human. Before I joined [the Network of Adult Survivors of Child Slavery], I used to ask myself, 'Am I even a person?' Now, I see that I am a person just like everyone else. We do trainings in our neighborhood, we

go door-to-door, we educate people about the rights of children, and we find afterwards that they aren't the same people anymore. They are changed. - Member, Network of Adult Survivors of Child Slavery I was taking part in Child Rights Training in my neighborhood when two members of the [the Network of Adult Survivors of Child Slavery] shared their experience of being in domestic servitude as children. That's when I joined the [the Network of Adult Survivors of Child Slavery]. The stories we talked about in Child Rights Training helped me to come to realize that I was living in servitude when I was sent to live with my aunt. At the time...I didn't understand. I would ask myself, 'Why is this happening to me, I don't understand why this is happening.' As survivors, it's our duty to protect children. This is our message: don't mistreat any child living with you. Don't treat them like you treat your animals. Care for every child living with you as if they were your own children. - Member, Network of Adult Survivors of Child Slavery The Movement for Universal Access to Quality Education Since 2003, Beyond Borders has been developing unique and innovative approaches to addressing lack of access and quality of education in rural communities, which includes community organizing to build strong school networks that address barriers to education and improve the quality of education through teacher training. On La Gonve Island, Beyond Borders works in collaboration with the Matnwa Community Learning Center (MCLC), whose education methods were proven effective in a December 2014 MIT study that demonstrated high student literacy outcomes as compared with schools across Haiti. Beyond Borders is partnering with MCLC to scale their promising teaching methods to other La Gonve schools through outreach programming that includes teacher training, ongoing technical support, and material support. In 2018, Beyond Borders and MCLC worked with 25 schools to improve access, increase parental engagement, and increase teachers' use of participative teaching methods that increase student engagement and lead to greater learning outcomes. include: Increased engagement of the Ministry of Education in supporting the propagation of the MCLC model on La Gonve and nationally, as evidenced by the presence of the La Gonve Inspector's presence at MCLC workshops and by his outspoken promotion of MCLC's approach with other schools on the island. MCLC's Co-director was presented an award from the Ministry for contributions toward improving education on La Gonve. Employed the Model School District approach to build greater collaboration among schools on La Gonve and the entities that fund them. Two schools were supported to become model hub schools, receiving training and support to build their capacity as models for neighboring schools. Identified and deployed approaches that affordably increase accessibility (tuition matching) to 100% across model communities, ideally with government engagement. The teachers are providing higher quality instruction. Prior to MCLC's workshops, we were using a lot of corporal punishment to manage our classrooms. I wasn't

principal at the time, but, it was MCLC's training that gave our teachers techniques to manage classrooms without violence. Ever since the school began participating in MCLC's teacher training workshops, we have eliminated corporal punishment altogether. This has been one of the greatest changes in our school. Another major change we've seen has been the elimination of learning through rote recitation of lessons in French, with no comprehension. Now we work with students by creating a learning environment that engages them to create books using their own ideas.

- School Principal The Movement to Promote Economic Justice and Sustainable Livelihoods Beyond Borders and its partners also implement programming to increase sustainable livelihoods and economic justice among families most impacted by extreme poverty. To do this, Beyond Borders invests in three key programs that promote sustainable agriculture, food security, and rural economic development: 1. School Gardens: School personnel and students are trained and accompanied to cultivate organic vegetable gardens, and to employ lesson plans that use gardens as learning laboratories. Garden produce is sold to generate school revenue, supplies school feeding programs, and provides an emergency food source for school families.

2. Family Gardens: Parents who volunteer at school gardens are also trained and supported to cultivate organic vegetable gardens at home in their own backyards. Family gardens with rainwater harvesting systems improve food security and purchasing power for families. Participating families report increased household income from sale of produce and increased nutritional diversity of family meals. 3. The Family Graduation Program: Beyond Borders' adaptation of the Graduation methodology (pioneered by BRAC and brought to Haiti by Fonkoze) helps destitute families develop sustainable livelihoods and overcome critical vulnerabilities around housing, food security, health, and schooling. Beyond Borders' adaptation includes a child welfare aspect, together with standard program elements, including livelihoods training, ongoing coaching, temporary cash subsidy, distribution of productive

assets, health care, and dignified housing. 4. Sustainable Agriculture Training:

Beyond Borders and its partners conduct training for farmers to introduce use of sustainable agriculture techniques that improve production while avoiding environmental degradation. 5. Adult Literacy Classes: With a literacy rate of only 61%, large numbers of adult residents in rural communities are illiterate. Illiteracy impacts folks' ability to achieve life advancements, impacting a person's capacity to manage a small business, track and support her children's education, understand and defend her rights as citizen, and participate fully in faith communities and social groups. Beyond Borders and its partners provide a two-year adult literacy program to address this need and to increase numbers of literate adults more likely to get involved in community organizing and development. Literacy centers are supported to cultivate community gardens, which are used as learning laboratories while also teaching sustainable agriculture to literacy students and neighbors.

As a result of this work: " 99% of school aged children of Family Graduation Program graduates are attending school; " 100% of children of Family Graduation Program graduates are living at home, and not in domestic slavery situations; " Family Graduation Program participants multiplied productive assets from 482 assets distributed at program launch, to 1,380 productive assets collectively owned by participants after participation in the program: and, " 100% farmers' workshop participants reported applying a new sustainable gardening skill. Achievements for the year include: Expanded Family Graduation Program to five new communities, reaching 151 additional families. Altogether, 231 families in nine communities were supported to attain dignified work. Worked to improve ability to measure changes in household food security among Family Graduation Program participants. During the year, Beyond Borders and partners began rolling out Impact Atlas - an online project cycle management platform designed specifically for graduation programming. Provided 231 families with cash subsidies, two productive assets

each, intensive livelihoods training, weekly coaching visits, healthcare access, drinking water filters, and home repairs or construction. Trained 450 farmers in sustainable agriculture techniques. Delivered literacy instruction programming to 237 adults. Supported 15 literacy centers to cultivate community gardens.

Supported 36 schools to cultivate organic vegetable gardens and to implement a curriculum that integrates school gardens into lesson plans. Supported 150 families to cultivate home-based organic vegetable gardens, providing training, installation of rainwater catchment systems, and seed. Testimony: My husband and I have six children. I live in the Lakwa neighborhood of Matnwa, on the island of La Gonve. I joined the family garden program after a meeting I went to where [program staff] asked us if we'd be interested in planting a vegetable garden in our yard at home. I raised my hand, and that is how I came to participate.

They gave me a water storage tank, helped me prepare the soil and fence my garden, and I went to training to learn how to manage my garden. I also help out at my child's school garden. This garden has been so useful to me. There have been so many changes in my life because of it. I've sold vegetables and I've been saving in my savings account. I use the water from the rainwater storage drum to water my vegetable plants, to give my farm animals to drink, and to do laundry.

It's been so helpful for our family. - Family Garden Participant The Movement to End Violence Against Women and Girls: Rethinking Power Program Through its Rethinking Power program, Beyond Borders mobilizes communities to drive a social change processes to prevent violence against women and girls (VAWG) and HIV.

Beyond Borders takes this work to scale by providing technical support to local organizations to implement community mobilization in their own communities. Beyond Borders uses two promising methodologies to engage communities to prevent VAWG: 1. SASA!: A phased community mobilization methodology created by Raising Voices to prevent VAW, proven to cut the risk of intimate partner violence in half. Beyond Borders

conducted the cultural and language adaptation for Haiti, completing a five-year pilot in 2015. 2. Power to Girls: A phased community mobilization approach created by Beyond Borders to address violence against girls. In response to feedback from communities, Beyond Borders developed this phased, community mobilization methodology to be used alongside SASA! or by itself to promote social norms change to prevent violence against girls. Power to Girls equips community activists to mobilize schools, parents, community members, and girls groups to advance girls' safety, voice and agency. This year, Beyond Borders advanced two research partnerships. The Global Women's Institute (GWI) at the George Washington University is studying the impact of SASA! and Power to Girls as implemented by Beyond Borders in Haiti. Additionally, Beyond Borders was one of several participants in a study conducted by University of California San Diego (UCSD) and Raising Voices to assess what inputs are necessary for successful adaptation of SASA! to different places. UCSD is also studying the effectiveness of Beyond Borders' technical support programming. Specific achievements for the year include: Implemented SASA! and Power to Girls in eight communities in Haiti's Southeast Department. Implemented SASA! in seven additional communities on La Gonve Island SASA!. ? Trained 905 and supported volunteer activists to mobilize social norms change. ? Cultivated relationship with Haiti's Ministry of Women's Affairs to establish a strategic partnership.

Provided training and technical support to 36 Haitian organizations at varying levels of engagement to use SASA! and Power to Girls to prevent VAWG. This included launching new technical support programming to share and scale the new Power to Girls methodology, training 9 Haitian organizations and one in Tanzania.

Developed a curriculum that is now being used to train journalists to promote VAWG prevention. Supported formation of a local advocacy committee to pressure the Ministry of Education to make VAWG coursework mandatory in schools. Published

Power to Girls in Haitian Creole and began the English translation to facilitate adaptation by organizations in other countries. Formed a coalition with technical support partners to conduct joint fundraising, as many organizations receiving technical support from Beyond Borders have lacked funding to rollout SASA! and Power to Girls methodologies in their own communities after being trained. Testimony: I want to share how my life has changed since participating in Power to Girls. I didn't have the same power boys have. Now, my mother and father listen to me when I talk in the house, and they try to share chores between my brother and me. They give me more respect in my house and in my community. Before this, I couldn't speak up. - Girl Participant
